The Debtor is authorized, but not directed, in its discretion, to pay, honor, or otherwise satisfy premiums, claims, deductibles, retentions, retrospective adjustments, administrative fees, broker fees, and any other obligations that (a) were either due and payable on or related to the period prior to the Petition Date on account of the Insurance Policies, and (b) are, or become, due and payable or related to the period after the commencement of the Case.

4. Payments and setoffs on account of prepetition obligations under the Insurance Policies shall not exceed \$5,000.00 without further order of this Court.

5. The Banks are authorized, when requested by the Debtor, in the Debtor's discretion, to honor and process checks or electronic fund transfers drawn on the Debtor's bank accounts to pay prepetition obligations authorized to be paid hereunder, whether such checks or other requests were submitted prior to, or after, the Petition Date, provided that sufficient funds

are available in the applicable bank accounts to make such payments. The Banks may rely on the representations of the Debtor with respect to whether any check or other transfer drawn or issued by the Debtor prior to the Petition Date should be honored pursuant to the Interim Order or this Final Order, and any such Bank shall not have any liability to any party for relying on such representations by the Debtor, as provided for in the Final Order.

6. Nothing in the Interim Order or Final Order (a) is intended or shall be deemed to constitute an assumption of any agreement pursuant to § 365 of the Bankruptcy Code or an admission as to the validity of any claim against the Debtor and its estate, (b) shall impair, prejudice, waive, or otherwise affect the rights of the Debtor, its estate, or any other party-in-interest with respect to the validity, priority, or amount of any claim against the Debtor and its estate estate, (c) shall impair, prejudice, waive, or otherwise affect the rights of the rights of the Debtor and its estate with respect to any and all claims or causes of action against any of the Insurers, or (d) shall be construed as a promise to pay a claim.

7. The Debtor is authorized to take any and all actions necessary to effectuate the relief granted herein.

8. Notwithstanding the applicability of Bankruptcy Rule 6004(h), the terms and conditions of the Final Order shall be effective and enforceable immediately upon its entry.
